A RESOLUTION OF THE BOARD OF SUPERVISORS OF HYDE PARK COMMUNITY DEVELOPMENT DISTRICT 1 RATIFYING, APPROVING AND CONFIRMING ALL PRIOR ACTIONS TAKEN BY THE BOARD OF SUPERVISORS OF THE DSTRICT; AND PROVIDING FOR SEVERABILITY, CONFLICTS AND AN EFFECTIVE DATE.

WHEREAS, Hyde Park Community Development District 1 (the "<u>District</u>") is a local unit of special-purpose government established and existing under and pursuant to the Uniform Community Development District Act of 1980, Chapter 190, Florida Statutes, as amended (the "<u>Act</u>"); and

WHEREAS, the District was originally established under the Act by Ordinance 2021-11 ("Ordinance "2021-11") of the Board of County Commissioners of Collier County, Florida ("BOCC") adopted by the BOCC on March 9, 2021; and

WHEREAS, due to a scrivener's error in the original petition to establish the District, the BOCC adopted Ordinance 2021-____ on November 9, 2021 ratifying and confirming the establishment of the District; and

WHEREAS, the District Board of Supervisors (the "<u>Board</u>") desires to ratify, approve and confirm all actions previously taken by the Board at its prior meetings including, without limitation, all resolutions previously adopted by the Board.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF HYDE PARK COMMUNITY DEVELOPMENT DISTRICT 1 AS FOLLOWS:

- 1. **RECITALS.** The foregoing recitals are true and correct and incorporated herein by this reference.
- 2. **RATIFICATION.** The Board hereby ratifies, approves and confirms all actions previously taken by the Board at its prior meetings including, without limitation, all resolutions previously adopted by the Board.
- 3. **SEVERABILITY.** If any section or part of a section of this Resolution is declared invalid or unconstitutional, the validity, force and effect of any other section or part of a section of this Resolution shall not thereby be affected or impaired unless it clearly appears that such other section or part of a section of this Resolution is wholly or necessarily dependent upon the section or part of a section so held to be invalid or unconstitutional.
- 4. **CONFLICTS.** All resolutions or parts thereof in conflict herewith are, to the extent of such conflict, superseded and repealed.

5. **EFFECTIVE DATE.** This Resolution shall become effective upon its adoption.
