## B. Casting of Ballots

## I. Determine Number of Voting Units Represented

Ms. Magaldi stated that there are a total of 823 voting units in the CDD.

A total of 716 of the 823 voting units are represented at the meeting today.

## II. Determine Number of Voting Units Assigned by Proxy

All 716 voting units represented at the meeting were assigned by proxy to Ms. Magaldi.

Ms. Magaldi stated that Neal Communities of Southwest Florida LLC assigned 466 votes via Landowner Proxy dated November 4, 2024. Ms. Magaldi is the appointed Proxy Holder for Neal Communities of Southwest Florida LLC.

Ms. Magaldi cast the following votes as Proxy Holder for Neal Communities of Southwest Florida LLC:
